On Survey of the community (population, business and NGO sectors) of Adjara Autonomous Republic

November- December 2005

General Analysis

In November of 2005 the Association of Protection of Landowners' Rights conducted the research of the Community in the Adjara Autonomous Republic within the scope of regional economic development planning. The purpose of the research was to study the public opinion regarding the current issues and the ways of their resolutions in the entire Adjara, as well as separate territorial units to be included in the Plan. The research covered all administrative-territorial units in Adjara and collected the opinion from all three public sectors, that is the Adjarian population, business and non-governmental organizations.

The different types of questionnaires were created within the scope of the research for thee different sectors of the public (population, business, non-governmental sector). Total of 7000 questionnaires were distributed, including 5959 (85%) among the population, 849 (12%) among the representatives of businesses and 210 (3%) among the NGOs.

This table describes the distribution of questionnaires according to the territorial units and sectors.

It should be noted that the advertising campaign was launched in November which explained the importance of participation of the public in the process of the research and increased their awareness. Video clip was financed by the Urban Institute and was aired on Adjara Television during one month. This campaign positively effected the results of the research. The number of collected questionnaires was 4904, that is 70% of the total number of questionnaires spread in the region.
